



PSC HOUSTON DISCLAIMER

The Participant, and the Parent(s) or Guardian(s), if the Participant is a minor child, grant authorization to the PSC Houston (Professional Soccer Club) to use photographs of the Participant for publicity purposes including Website, social media and print advertising content after his registration online.

INFORMED CONSENT/INSURANCE NOTICE:

PSC DOES NOT recommend to players to register to a team whose age group exceeds the player's actual age. It is our policy that all players compete at a level they are capable of both physically and developmentally. For a player to move up more than one normal age grouping will require approval from the Director of Coaching.

INSURANCE NOTICE: All injuries must be reported within 90 days of the date of the injury.

INFORMED CONSENT: I, the parent/guardian of the registrant, agree that we will abide by the rules of PSC Houston, and all its affiliated organizations. My/our child wishes to participate in soccer during the season of this registration. I/we realize risks are involved in my/our child's participation. I/we understand that the risk to my/our child includes full range of injuries from minor to severe, and the result could be death, paralysis, or other serious, permanent disability. I/we accept this risk as a condition of my/our child's participation.

PLAYING TIME:

As a parent/guardian I agree the primary focus of Professional Soccer Club Houston, is to ensure that the time spent learning and playing soccer is positive and rewarding for the player. I/We also understand that at the competitive level every effort will be made to play our child, however it is up to the coach to decide if a child does or does not play. THERE ARE NO GUARANTEES OF PLAYING TIME. I/we agree we will maintain a positive attitude towards the named player and the game at all times, and agree that the game is played by, for and on behalf of our children.

WAIVER OF LIABILITY AND DISCLAIMER:

I, the parent or legal guardian of the named player above, acknowledge that I am completely aware of the inherent risks associated with soccer, and hereby waive, release and PSC Houston as well as their officers, directors, and agents (collectively, the "Released Parties"), from any and all liability and responsibility in the event that I or the player become injured in any way during our participation in soccer events or activities associated with the Released Parties. I further state that I take full responsibility for any injury that may occur as a result of my or player's participation, and that I will not hold the Released Parties responsible for any aggravation or preexisting injuries prior to or during my or player's participation in any soccer events or activities associated with the Released Parties. If the participants have a chronic medical condition such as diabetes, seizure disorder, severe allergies or mental health disorder there might be special requirements that are applicable for the athlete to attend to PSC Houston (Professional Soccer Club) programs. EMERGENCY AUTHORIZATION:

I, the parent or legal guardian of the named player above, authorize PSC Houston their volunteers or representatives to act as my agent(s) to consent to medical, surgical or dental examination and/or treatment at a hospital or other health facility in an emergency where I can not be reached. I verify the named player above has no injury, or other conditions which would affect his/her ability to participate, or that I have advised in writing this organization of that condition, including my physician's name, and confirm the ability of the named player below to participate regardless. WAIVER AND RELEASE FROM LIABILITY:

In consideration of being permitted to compete or for any purpose participate in any way in the related activities, EACH OF THE UNDERSIGNED for himself, his personal representatives, heirs, next of kin, acknowledges, agrees and represents as follows:

HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE "PSC houston", and their affiliates or their employees, officers, directors and consultants, the promoters, participants, operators, officials, sponsors, advertisers, owners and lessees of premises used to conduct the activities and the programs and each of them, their officers and employees, all for the purposes herein referred to as "Releasees", from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all damage, and any claim or demands therefore on account of injury to the person or property or resulting in the death of the undersigned, whether caused by the negligence of the Releasees or otherwise while the undersigned is competing or for any other purpose participating in the Programs. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE or for any other purpose participating in the Programs.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the Programs may be dangerous and may involve the risk of serious injury and/or death and/or property damage. EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of Houston in which the Programs are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representation, statements or inducement apart from the foregoing written agreement have been made.

This waiver, release and indemnification agreement specifically embraces each and every Program sanctioned, authorized or promoted by said Releasees and applies to each and every Program, herein above mentioned, and has the same effect as if executed after each and every Program in which the undersigned participates so that the parties herein intended to be released and indemnified shall be fully and effectively released and indemnified to each and every Program herein above described.
